

Chairperson:

Lief Larsen welcomed and thanked everyone for coming the Chapter meeting. The Chapter has received the 2016 Top Flight sticker and Mike Wilson will put the sticker on the Chapter banner. John Dergosits noted that the Chapter has had Top Flight status since the program started.

Since the spring judging meet will be upon us quickly, please submit your registration for the Judging Meet early so Brian can schedule your preferred the judging assignments. The Chapter has received the new 1967 Judging Manual and copies are being made for the Chapter library. Brian noted that chapters are receiving black and white copies of the manuals instead of color copies which are given to others who purchase them.

Activities:

Mike Kalogridis noted that the next General Membership Meeting will be on 3/12/18 at 6:00pm at Scarborough's Restaurant. Lief Larsen noted that for the Chapter to qualify for Top Flight status additional activities will need to be planned: a social event (such as a summer picnic), road tour and participate in a charitable event (such as a Vettes In Perfection Cruise In which benefits Double H Ranch). Jim Sabia is willing to host a Tech Session.

New Business:

John Dergosits recommended that NCRS members should go to the National NCRS website to be sure that all of their vehicles that have been judged are on their user profile. Mike Kalogridis made a motion to alternate the Chapter meeting location between Scarborough's Restaurant in Latham and Sidelines Restaurant in Red Hook. There was an objection to the Red Hook location because of the traveling distance. Mike Kalogridis noted that maybe a location more centrally located (further north than Red Hook) could be considered. Mike Kalogridis amended his motion to hold the 3/12/18 Chapter meeting at Scarboroughs Restaurant in Latham, to hold the 4/9/18 Chapter meeting at Sidelines Restaurant in Red Hook and to look for a more central (further north than Red Hook) for

an alternate meeting location. Lief Larsen seconded the motion. Majority in favor with one opposed vote. The motion carried.

Jim Sabia noted that he would like the Chapter have an additional Chapter Judging Meet, possibly in the end of September 2018, at Joe Verrillo's garage in Clifton Park (Prestige Motor Car Co.) and additionally Jim would like the Chapter to co-host with another Chapter a Regional Judging Meet in September or October 2019. John Dergosits reminded everyone that NCRS members should go to the National NCRS website to be sure that all of their vehicles that have been judged are on their user profile.


New Business:
